

Terms of Use

Effective Date / Last Updated: February 28, 2022

These Terms of Use (“**Terms**”) govern your access to and use of our website (“**Site**”) made available to you by Schoeneck Containers, Inc. d/b/a Radius Packaging (“**Radius**,” “**we**,” “**us**,” or “**our**”), whether or not you complete a transaction with Radius or through the Site.

BY ACCESSING OR USING THE SITE, YOU AGREE TO THESE TERMS, AND OUR USE OF PERSONAL INFORMATION IN ACCORDANCE WITH OUR [PRIVACY POLICY](#). IF YOU DO NOT AGREE WITH THESE TERMS OR OUR [PRIVACY POLICY](#), DO NOT ACCESS OR USE THE SITE.

We may modify these Terms at any time. All changes will be effective immediately upon posting to the Site. Material changes will be conspicuously posted on the Site or otherwise communicated to you. By using the Site after changes are posted, you agree to those changes.

1. **Privacy Policy.** We may collect certain information about you and about your use of the Site as described in our [Privacy Policy](#), which is incorporated into these Terms. DEMANDS, COMPLAINTS, ACTIONS, DAMAGES, JUDGMENTS, SETTLEMENTS, FINES, PENALTIES, EXPENSES, AND COSTS (INCLUDING WITHOUT LIMITATION REASONABLE ATTORNEYS' FEES AND OTHER LEGAL FEES) THAT ARISE OUT OF OR IN CONNECTION WITH (A) YOUR VIOLATION OF APPLICABLE LAWS, (B) YOUR MISUSE OF THE SITE OR ANY CONTENT, (C) YOUR BREACH OF THESE TERMS OR ANY OTHER TERMS ON THE SITE; AND (D) YOUR INFRINGEMENT OR MISAPPROPRIATION OF RADIUS' OR ANY THIRD PARTY'S INTELLECTUAL PROPERTY. - 24. Governing Law.** Unless otherwise required by applicable law, these Terms, and your access to and use of the Site, are governed by the laws of the State of Wisconsin, without regards to its conflict of laws principles. Unless otherwise required by applicable law and subject to the following Section, venue is exclusively in the state or federal courts, as applicable, located in Waukesha County, Wisconsin. The parties expressly agree to the exclusive jurisdiction of those courts. Any cause of action or other claim brought by you with respect to the Site or Content must be commenced within one (1) year after the cause of action or claim arises.
- 25. Terms Applicable to New Jersey Customers.** No provision in these Terms shall apply to any consumer in New Jersey if the provision limits remedies for (i) negligence, (ii) products liability claims, (iii) the punitive damages laws, (iv) the New Jersey Uniform Commercial Code, or (v) failure to reasonably protect against harm arising from certain criminal acts of third parties (e.g., computer hacking and identity theft). The provisions of these Terms concerning the exclusion or limitation of certain damages are not applicable in New Jersey with respect to statutory damages, punitive damages, loss of data, and loss of or damage to property. Radius reserves all rights, defenses, and permissible limitations under the laws of New Jersey and under the laws of your state of residence.
- 26. Videos; Embedded Content.** The Site may contain videos and embedded content provided by YouTube, Vimeo and other third parties, including visible content and/or feeds scripts embedded in the Site' code. YouTube, Vimeo and such third parties may collect data about how you interact with such content. You may not assign your rights or delegate your duties under these Terms without our prior written consent. These Terms inure to the benefit of Radius' successors and assigns.
- 28. Entire Agreement.** These Terms, the [Privacy Policy](#), and any terms posted throughout the Site (if any) are the entire agreement between you and Radius with respect to your access to and use of the

Site and its Content. In the event of a conflict between these Terms and our [Privacy Policy](#), our [Privacy Policy](#) will control.

- 29. Waiver.** Radius' failure to enforce any provision of these Terms will not constitute a waiver of that provision or any other provision. Any waiver of any provision of these Terms will be effective only if in writing and signed by Radius.
- 30. Severability.** If any provision of these Terms is held invalid, void, or unenforceable, that provision will be severed from the remaining provisions and the remaining provisions will remain in full force and effect. The headings in these Terms are for convenience only and do not affect the interpretation of these Terms.
- 31. Electronic Communications.** These Terms and any other documentation, agreements, notices, or communications between you and Radius may be provided to you electronically to the extent permissible by law. Please print or otherwise save a copy of all documentation, agreements, notices, and other communications for your reference.
